



Tuition Fees 2011-12 – JK to Grade 6 International Students

Tuition Fees

International and non-resident Canadian students pay the Application Fee, the Enrolment Fee and the Deposit to hold their place at Counterpoint Academy™. The balance of tuition fees for the school year is paid in full by August 1st 2011. Our 2011-2012 Tuition Schedule:

Application Fee

A non-refundable Application Fee of \$100.00 for a new student is payable with his or her application.

Enrolment Fee

Upon acceptance to the school, there is a one-time, non-refundable, new student Enrolment Fee of \$500.00. The Enrolment fee is used to fund building rehabilitation and ongoing property obligations, and is due with your deposit.

Registration Deadline – Returning Families

The registration deadline for returning families is March 1, 2011. Any returning families who register after that date will be treated as a new family and subject to the new student Enrolment Fee of \$500.00.

Curriculum Outings, Cultural Events and Phys. Ed. Programs

All school curriculum based outings, cultural events and Phys. Ed. activities are mandatory as part of the programme and are included in the above tuition rate, regardless of attendance. Curriculum Outings, Cultural Events and Phys. Ed. Programs are non-refundable.

Miscellaneous Fees

Miscellaneous fees may be charged and include, but are not limited to before or after school care, specialty clubs, tutoring, private lessons, Grade 6 graduation and replacement costs of lost or damaged items or property. Miscellaneous fees are billed separately and are non-refundable.

International Students on Student Visas

Children who do not speak English take lessons in English as a Second Language (ESL) to help the students become part of the school community more easily and quickly. The cost for this private tutoring is not included in the tuition. The cost of English Language tutoring will be calculated based on individual needs and to be paid in full before the child begins school in September. Counterpoint Academy™ requires that students live with a parent during the time of their enrolment at the school.

Service Charges & Overdue Accounts

All invoices are due upon receipt, and the service charge is \$30.00 for any returned cheques. Counterpoint Academy™ charges interest at the rate of 1% per month on all overdue accounts including, but not limited to, tuition payments, supplies billings, outing costs and other charges.

I/we understand that any interest charges incurred as a result of late payment will be added to my account. Overdue accounts may result in suspension of the student.
