



# CAW Tuition Fees 2011-12 – JK to Grade 6

## Tuition Fees

JK to Grade 6 parents have two payment options from which to choose;

### Payment Option #1

There is a 10% reduction in the Tuition Fees for third and subsequent children.

## School Supplies

The Tuition Fees above include an allowance for School Supplies, which includes textbooks, workbooks, and consumable materials that are required and distributed to the students.

## Outings & Miscellaneous Fees

All school outings and off-site Phys. Ed. activities are mandatory as part of the programme and will be billed separately, regardless of attendance. The Ski Days are optional and will be billed based on attendance, rental requirements and usage of the ski bus. Children who do not attend are required to stay at home on these days. In addition, miscellaneous fees may be charged and include, but are not limited to the overnight trips for students in Grades 3 to 6, Grade 6 graduation and replacement costs of lost or damaged items. Outings and Miscellaneous fees are billed separately and are non-refundable.

## Registration Deadline – Returning Families

The registration deadline for returning families is March 1, 2011. Any returning families who register after that date will be treated as a new family and subject to the Application Fee of \$100.00 per student. This is to ensure that parents recognize the importance of timely re-registration as class size and staffing levels are based on enrolment.

## International Students on Student Visas

International students on Student Visas pay the Application Fee and their first deposit of \$1500.00 to hold their place at Counterpoint Academy West™. The balance of tuition fees for the school year is paid in full by August 1<sup>st</sup>. Children who do not speak English take lessons in English as a Second Language (ESL) to help the students become part of the school community more easily and quickly. The cost for this private tutoring is paid in full before the child begins school in September. Counterpoint Academy West™ requires that students live with a parent during the time of their enrolment at the school.

## Service Charges & Overdue Accounts

All invoices are due upon receipt, and the service charge is \$30.00 for any returned cheques. Counterpoint Academy West™ charges interest at the rate of 1% per month on all overdue accounts including, but not limited to, tuition payments, supplies billings, outing costs and other charges.
